With the conclusion of Part II of the sale series, "Iconic Wines from Joseph Lau" totalled over HK\$125 million / US\$16 million overall. "[An Immaculate European Connoisseur's Collection Part II](#)" and "[The Cellar of a Meticulous Wine Lover](#)" continues to welcome bidding online until 6 December.

With an overall total of over HK\$125 million, the results today – together with Part I earlier in April – are a testament to the impeccable quality of the bottles Joseph Lau so brilliantly amassed.
